The current version of **Citrix ShareFile for iPhone and iPad** was tested for conformance with Section 508 of the Rehabilitation Act, specifically, the US Access Board's Technical Requirements. This product was tested as of **August 1, 2017**, and is only valid for the version and date it was tested.

Assistive technology products used as part of testing included iOS 10.3.2 accessibility features: VoiceOver screen reader, Zoom screen magnification, invert colors, bold text and large font.
